With over 800 drivers operating across 750 vehicles, from box trucks, DOT delivery trucks, pick-up trucks, vans and SUVs, this approach placed a heavy administrative burden on a small team.

"In 2025, people have too many logins. If I can eliminate one for my drivers, that's a win."


