Introduction

One of the largest personal line carriers in Utah has long been committed to providing exceptional service to its members by delivering hyper-local insurance experiences. With great pride in a legacy that extends beyond a century and a steadfast commitment to its members, they are committed to delivering unmatched care, dependability, and peace of mind.

The Challenge

With a focus on leveraging data to drive underwriting decisions, the carrier faced significant challenges concerning the price and quality of data provided by LexisNexis, its primary vendor. As they sought to increase profitability to remain competitive, the rising costs associated with LexisNexis's data placed a significant financial strain on their new and renewal business. In fact, the carrier was unable to check 95% of their renewal book for new activity, leaving them vulnerable to potential risks and premium leakage for over 180,000 policies. The insurer also had concerns about LexisNexis' data quality, which impacted its ability to assess risk consistently and accurately.
